Our Sovereignty is under threat.


Since the inception of the Irish State, we have always held a position of neutrality during wars between other countries.

Your Right To Own Property Is Under Threat



The Thirty-ninth Amendment of the Constitution (Right to Housing) Bill 2020

The bill proposes to insert, after section 2 of Article 43 of the Constitution:

- 3.1 The State, in particular, recognises the common good as including the right to secure, affordable, dignified housing, appropriate to need, for all the residents of Ireland and shall guarantee this right through its laws, policies and the prioritisation of resources.
 - 3.2 The State, accordingly, shall delimit the right to private property where it is necessary to ensure the common good and to vindicate the said right to housing for all residents of Ireland.



On the passing of this bill the state would have the authority to requisition your home under a compulsory purchase order if it is deemed necessary for the "common good"

What conditions will cause the Government to "delimit" the owning of private property?

It is not a bill for the right to own your own private home, but a right to be housed as the government sees fit.

This bill alarmingly has the potential for confiscation of people's private property to be repurposed for the "common good".

AN INTERNATIONAL TREATY ON PANDEMIC PREVENTION AND PREPAREDNESS

In Jan 2022 the WHO proposed that all member states sign a new treaty to extend the International Health Regulations 2005 Treaty.

If signed by Stephen Donnelly, the WHO takes precedence over the Constitution of Ireland in the event of a pandemic or "other type of threat or disaster".

Our sovereignty is being stolen away by an institute that puts profit and control before individual health.

Your right to decide if and when to have medical treatment will be taken away.

The people have not been given the opportunity to vote on this extremely important handover of power.
